I specifically understand that I am waiving and forever releasing and discharging FRO, RAC, Minersville, Gulla, property owner, and their respective owners, members, shareholders, owner's family members, shareholders' family members, insurers, professionals, directors, officers, affiliated and/or related companies, employees, agents, successors and assigns from any and all claims, demands, damages, and/or causes of action that I may presently have or which may arise in the future. This waiver and release is effective for all acts and/or omissions, neglect or otherwise, including but not limited to any conduct by any entity and/or person, any conditions of the land, whether natural or artificial, and/or acts and/or omissions of any other participants.

3. Event. I acknowledge, understand and agree that I am only permitted to access the Event Property on the designated trails set forth for the Event on the dates and times designated for the Event. I acknowledge, understand and agree that I am <u>not</u> otherwise permitted on the Event Property and, in the event that I am on the Event Property and/or on the property of any property owner without that property owner's express permission that are not part of the designated trail, I will be considered a trespasser and, FRO, Minersville, Gulla, and/or the property owner may take any and all legal actions to prosecute me as a trespasser. - 6. <u>Miscellaneous</u>. This Waiver, Release and Indemnification shall be construed and enforced with the laws of the Commonwealth of Pennsylvania, and that if any portion hereof is held invalid, it is agreed that the remainder of this Waiver, Release and Indemnification shall continue in full legal force and effect. The captions used herein are for convenience purposes only. The Court of Common Pleas in and for Schuylkill County, Pennsylvania shall have exclusive jurisdiction and venue for any action arising out of my participation in the Event and/or related to this Waiver, Release and Indemnification.
